Fingerprinting and background checks are required for entry to the full-time student teaching internship only. Students completing early field experiences that begin freshmen year enter buildings as volunteers and follow district requirements some districts do require fingerprinting. Students must pass all initial Praxis tests before entry to the full-time teaching internship. The Praxis Core is the "basic skills test". The state will accept minimum SAT/ACT scores in lieu of Praxis. Students complete early fieldwork prior to the examination of standardized test scores.

Teacher candidates are required to spend 100 days in a supervised student teaching internship experience at a formal Professional Development School. While mentoring and support is ongoing by PreK-12 staff, each intern receives 15 hours of on-site support from IHE faculty but they are not the teacher of record. Each student teaching intern is supervised by a mentor teacher that receives a stipend and a site coordinator. Two supervised experiences are required by students before they apply to the formal program. A dispositions rating is required by K-12 staff as part of the application package. Supervised clinical field experiences are also open to students interested in pursuing alternative preparation routes to teaching after graduation such as Teach for America, Urban Teachers, and TNTP or private school employment.

Students begin field experiences during the freshman year. Student teachers complete action research projects that are linked to the improvement needs of our partnering schools. We have formal Professional Development School (PDS) partnerships with the area Title 1 schools that host our students. Students also complete field work visits to nearby urban schools and bilingual schools as part of course requirements.

College faculty members model the use of technology in teaching college classes. Interns are required to employ interactive whiteboards and other technologies in pedagogy training and in student teaching. Students were trained to use specialized applications including Nearpod and Zoom to support remote teaching and continue to leverage those technologies. Interns participate with their school mentors in collecting and analyzing student achievement data- for planning future instruction using LEA systems. Interns are required to produce portfolio artifacts that demonstrate the effective use of technology. The portfolio process for interns employs a web-based tool. Interns are required to demonstrate mastery of the Maryland Teacher Technology Standards (MTTS).

Our undergraduate program only prepares general education teachers at both the elementary and secondary levels, but they practice at inclusive schools. All students take the course EDU 330 Diversity and Inclusion prior to admittance into the student-teacher program. The course is a rigorous introduction to special education that prepares general educators to meet the needs of students with disabilities in the general education classroom and work effectively with special educators, paraprofessionals, and related service providers. Strategies to effectively teach students with high-incidence disabilities are taught in all instructional methods coursework. Students must demonstrate the ability to design with and implement Universal Design for Learning (UDL) principles.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Student teaching interns are required to attend IEP meetings with their mentor (cooperating) teachers. Students examine mock IEP meetings during EDU 330 Diversity and Inclusion course prior to student teaching.
